**2017 Zoning Ordinance Clean Up (Local Coastal Program Amendment LCPA17-0003/Zone Text Amendment ZTA17-0001/Specific Plan Amendment ZTA17-0001):** A zone text and Dana Point Specific Plan amendment to various portions of the Zoning Ordinance, to address typographical errors, clarify sections of the code to better assist the public, and make modifications consistent with recent State law changes. The Dana Point Specific Plan amendment is directly related to uses allowed above the ground floor in the Coastal Visitor Commercial (C-VC) zoning district.

Any action or proceeding to attack, review, set aside, or void any decision of the Dana Point City Council is controlled by Section 2.50.010 and Section 2.50.020 of the Dana Point Municipal Code. In any such action or proceeding seeking judicial review of, which attacks or seeks to set aside, or void any decision of the Dana Point City Council, shall be limited to those issues raised at the hearing as provided in Chapter 2.50 of the Dana Point Municipal Code.
