## **PUBLIC COMMENTS**

Dorean Ora, Laguna Niguel, Grand Jury representative, stated that November has been declared as Grand Jury Awareness Month by the Board of Supervisors. She described the purpose of the Grand Jury and their duties. She added that the Grand Jury was the citizen's watchdog.

Pam Tappan, Capistrano Beach, offered condolences to the family of Doris Walker. She spoke about the workshop that was held for the Doheny Village and felt that staff had done an outstanding job. She encouraged the residents of Capistrano Beach to get involved.

Mary Jeffries, Dana Point, spoke regarding the Coastal Commission hearing that was held recently regarding the mobile home park on Del Obispo.

Todd Glen, Dana Point, felt that the City's extension of the contract for the EIR preparation of South Shores Church avoided full disclosure of the geotechnical and pertinent details. He stated that the City Council should place the item on the agenda to facilitate open, public dialog.

City Manager Chotkevys asked staff if they had received the reports yet.

Director Butterwick replied that the EIR was still being prepared, including the geotechnical information. He stated that at some point that information will be submitted to the City, and will then be subject to an independent peer review initiated by the City which is part of the EIR process.

Hal Brice, Dana Point, thanked the City Council for the support on the issue of the Strands mid access. He felt that misinformation was being spread about the access to the beach.

Barbara Wagner, Dana Point, thanked the City Council for their support and spoke about her experiences living on the Strand.

Kenneth Wagner, Dana Point, stated that his home is right next to the mid Strand access and felt that if the gate were open all of the time, that it would be unsafe for the residents.

Susan Parmelee, San Clemente, spoke regarding the homeless population in South County and the lack of emergency shelters.

Leslie Davis, San Clemente, felt that the City's Code was limiting for the homeless. She stated that Capo Calvary was the best location for a shelter. She encouraged the City Council to direct the Community Development Director to issue a special event permit and to waive all permit fees.

Steven Hagy, Dana Point, spoke regarding the homeless shelter at Capo Calvary Chapel and felt that the church's hands were tied in trying to help.

Denise Erkeneff, Dana Point, spoke regarding the mid Strand access way. She stated that over 2,400 people have signed their on-line petition asking for the gates to be removed. She felt that the hours for closing the gates were unrealistic.

Karin Schnell, Dana Point, invited everyone to the artist's reception on November 17, 2011, 6-8 p.m. at the Dana Point Community House for the new Dana Point book. She stated that books can be purchased at dpcoastalarts.org. She reported that Terminal C had opened today at John Wayne Airport and that the first permanent art piece had been installed.

Alan Warren, Laguna Beach, spoke regarding the access at mid Strand beach. He stated that the development there has provided better access than what was available before. He supported the City Council's position on the gates.

Richard Foley, Dana Point, spoke regarding the mid Strand access. He felt that the people who use the mid access don't stay on the path and added that it should be controlled like the accesses on the north and south sides.

Reverend Loc Tran, Dana Point, spoke regarding the homeless of Dana Point. He asked for an extension of the days and number of people who can be sheltered at Capo Beach Calvary.

Mayor Schoeffel asked if there was a specific Zoning Ordinance with respect to shelters.

Director Butterwick replied that was correct.

Mayor Schoeffel stated that it was his understanding that if there was a specific Zoning Ordinance that a special use permit could not be approved.

City Attorney Munoz replied that he was correct.

Mayor Schoeffel stated that if this Council decided to put an item on the Agenda, the item would be to amend the specific Ordinance with regard to shelters. He asked what that would entail in terms of process.

Director Butterwick replied the process would consist of an Ordinance amendment of the City's Zoning Code beginning with a public hearing before the Planning Commission, the Planning Commission would then make a recommendation to the City Council, the City Council would ultimately rule on that item and it may also require a review by the Coastal Commission.
