RE: Support of Single-use Bag Ban Ordinance

Dear Mayor Schoeffel and City Council Members:

This letter, on behalf of Surfrider Foundation South Orange County Chapter, is sent in addition to our September 26, 2011 letter stating that the organization stands in strong support of a Single-use Bag Ban Ordinance. We understand that the City is prepared to follow the Manhattan Beach bag ban model. While that ordinance was recently upheld as a valid act of a municipality, in compliance with the California Environmental Quality Act through the use of a Negative Declaration and Initial Study review, by the California Supreme Court in the Save the Plastic Bag Coalition v. Manhattan Beach case, we urge the City to go beyond the Manhattan Beach model and include regulation on single-use paper bags as well. In the statewide trend of single-use bag regulation and corresponding transition to reusable bags, most cities in the past two years have included a fee on paper bags in addition to a ban on single-use plastic bags. In response to the lawsuits brought against Oakland, Manhattan Beach, and Palo Alto, starting in 2010 localities engaged in the "second generation of bag bans" have adopted regulations on bags in the form of plastic bag bans plus fees on paper bags. The fees range between five and fifteen cents per bag. The hope is that these fees will encourage customers to bring their own bags, prevent an increase in the use of paper bags.

In 2010, Los Angeles County enacted a plastic bag ban which also incorporated a tencent fee on paper bags. (See attached LA County Ordinance for specific language). Long Beach, Calabasas, and Santa Monica quickly followed suit and enacted their own similar bag ban ordinances with ten-cent fees on paper bags. Also in 2010, the City of San Jose passed a plastic bag ban that imposes a ten-cent fee that increases to twenty-five cents in two years. In January 2011, Marin County enacted a ban that also imposes a five-cent charge on paper bags. Santa Clara County passed a single use plastic ban with a minimum fifteen-cent charge on paper bags.

The charge on paper bags is important because it rebuts anticipated arguments from the Save the Plastic Bag Coalition and industry groups that 'a ban on plastic bags will lead to increased paper bag usage and therefore will be more harmful to the environment.' By

banning and dis-incentivizing the consumption of all single-use bags, the City will not fall prey to the "plastic versus paper" arguments that the plastics industry are likely to bring forward. By regulating all single-use bags, the City can truly make this issue a "single-use versus reusable" debate, in which the clear answer that is better for the environment and efficient consumption of our natural resources is the reusable bag.

In drafting a future ordinance, Surfrider Foundation encourages the City of Dana Point to include the following to make for a strong single-use bag regulation:

- A requirement that stores to charge a 5-10 cent fee on paper bags in addition to the single-use plastic bag ban so that use of all single-use bags will be deterred by the ordinance. Not only will a ban on plastic bags with a fee on paper bags encourage Dana Point consumers to bring their own reusable bag to the store, this type of ordinance would also be more congruent with the statewide proposals, like AB 1998 (Brownley) which very narrowly missed passage through the state legislature in 2010. (A similar statewide proposal is likely to appear in the future);
- Strong language to cover food providers and farmers markets in addition to other stores;
- Requirement for 100% recycled paper bags, when offered for sale in stores; and
- Ban on all types of plastic bags, including "biodegradable" bags, which pose the same risk to the marine environment and do not readily break down in the ocean.

Dana Point can lead the County in setting strong laws to regulate marine trash and protect our valuable coastal resources. Surfrider Foundation strongly supports the passage of the single-use plastic bag ban with a fee on paper bags to protect the oceans, waves and beaches that Dana Point citizens and visitors love.

I know that a voluntary program to stop the use of Styrofoam started by Brad Gross and of the OC Dana Point Harbor last year has been very successful, and the merchants do support a ban on Styrofoam and would support the city's efforts as well.

Dear Mayor,

I am 1000 percent behind the banning of plastic bags in the City of Dana Point. However, first we need to ban cigarettes. Then we need to ban glass bottles. Then we need to ban plastic candy wrappers. You can ban as many products as you want and you still **won't** solve the problem.

Do you really want to replace one problem with another? On October 21, 2011 and article by Richelle Gonzalez at the Washington Times states that -

"Reusable grocery bags may be good for the environment, but they could be making you sick.

With Montgomery County set to impose a tax on disposable grocery bags that's designed to discourage their use, a new study has found that intestinal bacteria like E. coli flourish in unwashed reusable bags.

The study, published in the latest issue of the International Association for Food Protection's Food Protection Trends magazine, tested 87 reusable bags obtained at random from shoppers in California and Arizona.

Charles Gerba, a professor at the University of Arizona who conducted the study, found that 8 percent contained E. coli, among other harmful food-borne pathogens.

Putting a reusable bag through the wash can eliminate almost 100 percent of the bacteria. But the study found that only 3 percent of shoppers surveyed had washed their reusable bags between uses."

The implementation of a ban on plastic bags is only going to further hurt local business. They do not need any more regulations.

Plus, how are you going to prevent people from bringing plastic bags into Dana Point and littering? Are you going to fine them? Just think of all the money the city could make off the

tourists at the Festival of the Whales? The summer concerts? The Turkey Trot? And especially 4th of July?

Don't get me wrong, I want a CLEAN planet. Maybe the time would be better spent if the cities, the retailers, Surfrider Foundation and all the other wonderful environmental groups get together and work with the various manufacturers to come up with biodegradable plastic bags. If I am not mistaken, the technology is already available, such as the EPI dog bags that the city gives out.

Hi Brad,

First off, I'd like to introduce myself via email. I am the new Director of Local Government Relations for CGA. I tried to call you, but they mentioned you were not in today. I wanted to talk to you about the plastic bag ordinance scheduled for a vote on Monday night.

Our industry is very comfortable with a plastic bag ban, but we feel like it is unfair to just regulate one entity. Thus, we encourage the City of Dana Point to enact not just a ban on plastic, but a mandated charge for paper bags across all retailers.

In 2007, San Francisco passed a similar ordinance that just banned plastic, no charge on paper and we found that people just switched from plastic to paper. This is economically very problematic for our retailers, as a plastic bag costs \$.01/bag, while a paper bag costs \$.05-\$.15/bag – a huge cost increase for retailers. **Stores were losing \$60K-\$80K a year, per store because customers wanted paper bags**. Obviously, this is a huge burden for retailers who already run at very tight margins.

However, with dozens of jurisdictions following similar models of a ban on plastic, charge for paper, we found that that charge really incentivized customers to bring in reusable bags. Anecdotally, we've found that before an ordinance like this has passed, about 25% of customers brought in reusable bags. After the ordinance passed (and after the implementation period timeline) within 30 days, over 80% of customers used reusable bags. The charge on paper is a very strong incentive for customers to bring in reusable bags. We recommend a charge on paper anywhere from \$.05-\$.15, with \$.10 being the norm.

Again, we are comfortable with the plastic bag ban, we like that you've included all retailers, we like an implementation time period, but we must oppose if a charge on paper is not included.



Dear Dana Point City Council Members,

The Pacific Marine Mammal Center has functioned as the sole marine mammal rehabilitation facility in Orange County for 40 years with a mission to:

- Rescue, medically treat, and rehabilitate Pinnipeds (seals and sea lions) and cetaceans (dolphins and whales) that strand along the Orange County coastline due to illness or injury;
- Release healthy marine mammals to their natural habitat, while preserving species diversity;
- ❖ Increase public awareness of the marine environment through education and research.

The Pacific Marine Mammal Center is greatly concerned with the environmental issues that impact marine life. We at the center see, on a regular basis, the negative and life threatening results of trash and other materials that have been allowed to invade marine environments.

In a large jar in our display case floats the stomach contents of a young sea lion pup, "Ping" who came to our center maintentished and died despite our best efforts to save him. The jar contains one <u>plastic grocery bag</u>, two sandwich bags, <u>multiple pieces of Styrofoam</u> and four colorful balloons. Ping's plight is one of the devastating results of marine pollution that is impacting the world's oceans at an increasing level. Plastic marine debris affects at least 267 species worldwide, including 86 percent of all sea turtle species, 44 percent of all sea bird species, and 43 percent of marine mammal species. (Marine Debris — Sources, Impacts and Solutions, Coe, J. M. and D. B. Rogers)

"As much as 80 % of all marine debris comes from land-based sources, blown there by the winds or carried there by storm drains and rivers. People, wherever they are, need to learn to dispose of, or recycle waste better. It's a behavioral issue," says Seba Sheavly, an authority on marine debris and consultant for Ocean Conservancy International Costal Clean up. While Pollution prevention and storm drain education are incorporated into all of the Pacific Marine Mammal Center's education programs, the students who are educated about reducing plastic marine will not be your city's primary consumers until 2025. Policies to protect our ocean and coast from further pollution are needed now as the amount of degradation from plastic we have seen in the last ten years has been considerable.

We strongly support and encourage the City of Dana Point in its efforts to reduce and/or control waste materials that harm marine and other physical environments.

My family firmly opposes the Dana Point code amendment that would prohibit distribution of plastic bags at Dana Point retail stores! I think that this ban will lead to:

- 1. Fewer people shopping at Dana Point grocery stores (they will simply go to Laguna Niguel or San Clemente); hence lower revenue for the city
- 2. Negligible reduction in plastic bag litter for the following reasons:

Plastic bags for myriad other things will still be around and available; as will the grocery bags, for a fee

1 Most of the ocean litter washes down the

river upstream from Dana Point

3. Greater expense and greater inconvenience for Dana Point residents with little to no actual impact

We use those bags for a variety of purposes that plastic bags are uniquely suited for--trash can liners, picking up dog poop, cleaning the cat litter box, bringing home wet towels/swimsuits from the beach and garbage collection in the car, to name a few. While I understand there is a litter and ocean pollution problem, I don't see how penalizing the responsible residents of Dana Point by charging for bags will solve that. Surely other ways are available to address the pollution issue without increasing consumer costs at the grocery stores during the worst economic times since the Great Depression. We need sensible, effective solutions, not "feel-good" pseudo-solutions, in my opinion.

The facts about plastic bags are:

- They are 100% recyclable
- * Paper takes up the lion's share of landfill space--not plastic bags
- * It takes more natural resources to make a paper bag than a plastic one.
- * It takes 91% less energy to recycle a pound of plastic than it takes to recycle a pound of paper

Dear Council Members:

The purpose of this letter is to encourage you to scrap a plan to ban plastic bags:

- Plastic bags cost less to produce than paper and are inexpensive to recycle.
- Canvas bags have proven to be a health risk when meat, dairy, or produce leakage and residue remain in the bag undetected.
- Plastic shopping bags later serve me as trash bags, a laundry bag on trips and containment for miscellaneous articles I store. Plastic bags are better than paper ones in some ways. They compress into a small wad. I carry one in a pocket most times and keep one in the car because they are so handy.
- Banning plastic shopping bags won't reduce my need for them. Rather I will have to purchase ones in the store that cost more and require more petroleum to produce.

If the motivation for this citywide ban is the environment, I applaud the intent but question the effectiveness and ramifications and fear unintended consequences. How about the decision to make cheap gasoline out of corn? Seen the price of food lately?

Although speaking as a resident I am also on staff at the Ocean Institute. We teach school children and the public to be good stewards of the ocean. Much trash ends up in our ocean via runoff. I occasionally see a plastic bag on the beach or in the water. But the number that end up there is miniscule compared to the number of bags in circulation. Why prevent me from having the use of plastic bags because of a few that go astray? If you think government rather than the marketplace needs to do something then I encourage you to find a way to catch those responsible for plastic bag litter, but don't deprive the citizenry from this useful product.

By the way, if you really want to protect our ocean environment and friends that live in it your next target must be party balloons. Ban them from car dealerships, parades, and private celebrations. I see a lot more balloons at sea than plastic bags.

In conclusion we need to protect our environment. We also need to protect our rights. Pursue those who litter. But please protect my freedom to choose plastic or paper, or to bring my own canvas bag if that suits me. And protect our businesses so we can all shop in Dana Point without having to go a neighboring town where merchants are free to provide plastic or paper.

Dear Mayor Schoeffel,

I am writing to you regarding the proposed ordinance to ban single-use plastic bags in Dana Point, an issue due to come before your City Council on December 12. I strongly urge you to oppose this ordinance.

All of us share a desire to preserve and maintain a clean environment. At the same time, as elected officials, our primary duty is to preserve the liberty of the citizens we serve. Good intentions aside, a plastic bag ban will have little to no impact on reducing the presence of plastic bags in Dana Point Harbor or on the beaches — but will have a very real impact on Dana Point businesses and residents.

Dana Point attracts hundreds of thousands of visitors annually to its harbor and beaches from all over the county, and indeed, the world. However, this ban does not prevent visitors from stopping in the cities where they live, or even in cities bordering Dana Point, to purchase food, refreshments or other items and then bringing those goods, and the plastic bags they come in, into Dana Point.

The proposed ban would not prevent plastic bags originating along other points up the coast from entering the harbor or effecting beaches adjacent to Dana Point.

Furthermore, retail stores at Dana Point Harbor and the food concession at Doheny State Beach are on county and state property, and are likely not to be subject to this proposed ordinance.

At the same time, this ban will impose a very real burden on Dana Point retail businesses. Paper and reusable bags are significantly more expensive than plastic bags, and forcing businesses to use paper and reusable bags only amounts to a costly mandate on businesses with no demonstrable environmental benefit.

Just as importantly, banning local businesses from being able to use plastic bags is the same intrusive, anti-free enterprise regulatory approach that is driving businesses and jobs away from California. California businesses need less regulation, not more – whether from federal, state or local governments.

If local business owners want to use only reusable and paper bags, that should be their free choice and not imposed upon them by the city council.

As a former city councilmember myself, I understand the desire to do what you think is best for your city. It is my belief that freedom and voluntary action are the best approaches to this issue, and implore you to vote against any ordinance prohibiting businesses from using plastic bags.

While I try not to weigh in on city issues, I was asked by the Mayor, to offer testimony for the December 12th City Council Meeting regarding the plastic bag and Styrofoam ban. As such, I strongly urge the Dana Point City Council to oppose a plastic bag ban ordinance at their December 12 meeting. While I understand the sentiment and desire to taking action on an issue that deserves attention, a similar ban on plastic bags and Styrofoam failed to pass the State Legislature in Sacramento.

Even the most liberal members of our Legislature understood, after many hearings and shared information, the additional costs of these bans are passed directly to the consumer at a time when many are struggling financially. More to the point, new ordinances, regulations, fees, and taxes send the wrong message to our citizens and businesses community during this continuing recession.

There is no doubt we need to find ways to stop people from littering our beaches and parks. But to eliminate plastic bags from one source, such that people may still bring them into town and/or buy them from another source, will render the ordinance ineffective. I also dispute that plastic shopping bags are described as single-use. Many of us reuse the bags as trash can liners, and to store products many times over. Is the city going to ban baggies for food storage or store purchased plastic trash and lawn and leaf bags?

I recall that years ago we determined to switch from paper bags to plastic bags to "save the trees and the planet" and reduce landfill waste, as paper bags are more cumbersome to store and throw away. While they degrade faster than plastic they also take up more landfill space.



Dear Mayor Anderson,

The California Restaurant Association (CRA) respectfully opposes the proposed ordinance to ban polystyrene food service packaging.

The restaurant community shares the on-going concern over litter, particularly marine debris, and participates in many local communities throughout the state on litter abatement efforts. Marine debris is an issue that the industry takes very seriously. However, we believe that discriminatory selection and elimination of a given type of food service packaging is a shortsighted way to address the problem of litter. When litter reduction occurs on city streets, the amount of material that flows through drains, rivers and ultimately to the ocean is also reduced. Efforts should be aimed at reducing all composition of litter, not a single product, so that the overall volume of material reaching the marine environment is reduced.

As for the specific products targeted in this bill, polystyrene foam food packaging containers are among the most efficient for keeping foods fresh and hot or cold. That is why it is standard practice for ice cream, frozen yogurt and smoothie shops, amongst others, to use foam packaging.

For an industry characterized by razor thin profit margins of 5-6% on the dollar in a good economy, cost always has to be a consideration in addition to the functional value of a product. Schools, hospitals, nursing homes, non-profit food programs, delis, and family-owned restaurants are among the many institutions that rely upon polystyrene foam for its excellent insulation at an economical price. Alternative packaging materials are as high as 2-3 times more expensive, according to the nation's leading distributors.

Cost differences are felt differently by different sizes, types, and locations of restaurants and therefore have differing impact on the industry. The cumulative effect of additional cost pressures only serves to harm the industry.

In addition to the higher cost of alternative materials, the functionality of the products targeted under the proposed ban is outstanding. While some restaurants choose not to use foam products and others are under local ordinance bans on the product- many restaurants still choose to use the product because of its functional value being the best match for the type of food offered and it costs significantly less. Many operators are struggling with alternative products and the structural integrity of them. What works for a sandwich may not necessarily work as well for enchiladas, lasagna, soups, smoothies or frozen yogurt for instance. The type of food or drink being served matters very, as operators that are having their packaging options dictated to them by government entities, often have to use other materials within the alternative packaging to avoid leakage or "double cup" to properly preserve the temperature of certain items. This creates even more waste.

Foam is being recycled today in various regions and we support that effort and want to continue to help expand that effort, but we can't support discriminatorily banning certain types of food packaging and imposing higher costs on restaurant operators in Dana Point.

For these and other reasons, we respectfully must oppose the proposed ordinance and appreciate your time and consideration of our views.
