

**DIRECTIONS TO THE SOUTH COAST WATER DISTRICT COMMUNITY INFORMATION FORUM
DANA HILLS TENNIS CENTER, 24911 CALLE DE TENIS, DANA POINT (May 31, 6 PM)**

The Dana Hills Tennis Center is operated by South Coast Water District as a community service. Six of the eight tennis courts at the center are located on top of two District reservoirs. The tennis center is open to the public and parking is free. The facility is not gated and no code is required to enter.

However, it can be difficult to see the Dana Hills Tennis Center sign or the Calle de Tenis street sign from Golden Lantern, where you turn to drive into the facility. What's more, GPS and online driving directions to the tennis center can be misleading or wrong. **We hope that the local directions we've put together here may be helpful to you, should you need them.** Please tell us if you see how we might improve them. Directions from Golden Lantern at the intersection of PCH/ Del Prado

Travel approximately 1.5 to 1.6 miles north on Golden Lantern (away from the ocean). Make a right onto Calle de Tenis at the Dana Hills Tennis Center sign. Go 0.2 miles up the hill and into the tennis center parking lot.

Directions from Golden Lantern at the intersection of Stonehill Drive

Travel approximately 0.9 miles north on Golden Lantern (away from the ocean). Make a right onto Calle de Tenis at the Dana Hills Tennis Center sign. Go 0.2 miles up the hill into the tennis center parking lot.

Directions from Golden Lantern at the intersection at Camino Del Avion

Travel approximately 0.4 miles south on Golden Lantern (toward the ocean), and make a u-turn onto Golden Lantern north at the Dana Woods sign. Go 0.2 miles north on Golden Lantern and make the third right onto Calle de Tenis at the Dana Hills Tennis Center sign. Go 0.2 miles up the hill into the tennis center parking lot.

South Coast Water District's Community Information Forum, May 31, 6 – 7:30 pm, at Dana Hills Tennis Center will feature a presentation detailing our multi-year sewer tunnel project, a video shot inside the tunnel showing current conditions and project simulations, and Qs & As with project experts. The District will reconstruct the two-mile tunnel that runs deep inside the ocean bluffs of South Laguna and replace the sewer line within it that conveys a million gallons a day of wastewater for treatment. The sewer line serves approximately 8,500 residents in Dana Point and 3,500 residents in South Laguna. The 58-year-old tunnel runs from Three Arch Bay to Aliso Beach and is undersized, deteriorating and unsafe. It poses risks of injury to workers and damage to the pipeline, which could result in a significant sewage spill onto the beach and into the ocean.
