#### Volunteer of the Month - Bob Fowler

Administrative Secretary Weamire provided a PowerPoint presentation detailing Bob Fowler's military background and his volunteer efforts with VFW Post 9934. She stated that Bob joined Post 9934 in 2006 and since then he has held several positions. She added that during his service as Commander from 2009-2011 Bob was recognized by the Veterans of Foreign Wars United States as the All-State Team Post Commander for two consecutive years as well as the All American Post Commander. She stated that Bob's most notable community contribution was conceptualizing and fundraising to bring the American Vietnam Traveling Tribute Memorial Wall to Dana Point. She added that the Wall brought over 35,000 visitors to the city. Mayor Anderson presented Bob with the "Making a Difference" award and a Certificate of Appreciation for his efforts in the lives of the Veterans and his contributions to VFW Post 9934.

Council Member Brough removed this item from the Consent Calendar.

City Manager Chotkevys provided a staff report.

Mayor Anderson opened the Public Comments.

Ingrid McGuire, Dana Point, stated that she and her neighbors continue to be very concerned about the adoption of this ordinance. She felt that the onus would be put on the homeowners and that little would be done to create a true fire break.

Mayor Anderson closed the Public Comments.

Council Member Brough stated that his biggest concern with this item is that it puts the onus on the homeowner when the real fire threat is the vegetation in the surrounding canyon and Laguna Niguel. He felt that the City should discuss this issue further and see if there are other options.

Council Member Schoeffel agreed that anything the City could do to reduce risk of fire would be very appropriate. He asked if there was any substantial evidence in the record which would support the City not adopting this measure that was adopted by State law.

City Attorney Munoz replied that the Law states under Section 51179 of the Government Code that the City Council can exempt homeowners if there is substantial evidence to support findings. He stated that the code does not allow the Council to not adopt the map, only exempt properties in the area from compliance. He added that there were no cases of cities not adopting the map. He stated that if the City Council chooses to not adopt the map that there may be legal consequences. He added that his concern is that some could say that the City Council failed to exercise a mandatory duty which is one of the exceptions to the Tort Claims Act.

Building Official Sutton added that FEMA had provided a major portion of the funding for this updating effort and that FEMA may not be inclined to help rebuild if there is an issue. He stated that if there is no new development the existing homes will not be affected. He reported that staff was working with Orange County Fire Authority to develop a program voluntarily getting the residents involved to do the exterior fortification. He stated that he hoped to have a four-step program in place by the June 19 meeting with the Monarch Bay Terrace Association. He added that insurance representatives have said that they don't use the fire zone severity maps because they aren't updated often enough.

City Manager Chotkevys stated that he had asked staff to work with OCFA to create a Dana Point specific tool box approach that the City could offer to the residents that brings the various trade people together so that the City could provide assistance. He added that one of his concerns is not just Monarch Bay Terrace but the area in Monarch Beach that surrounds the canyon behind the high school as well as the canyon behind the development next to City Hall.

City Attorney Munoz reported that Mayor Pro Tem Weinberg recused himself from this item due to a potential conflict of interest and had left the Council Chamber.

City Attorney Munoz stated that Council Member Brough had sent him an email earlier today asking if the Council doesn't have a choice on this matter, why they were even voting. He replied that the City Council does have some choice under Section 51179 to make the map broader than what is required.

Building Official Sutton stated that if the map isn't adopted the City can't require 7A building fortification efforts.

Mayor Anderson felt that exempting properties would not make sense if the neighbors are not doing what they need to do to make their property as fire proof as possible. She asked what would be the purpose of exempting properties.

City Attorney Munoz replied that if the Council were to determine that a whole area was relatively newly built and built to standards that were so high that the City wouldn't have to worry about compliance with the provisions of 51182.

Council Member Bartlett stated that if the maps aren't adopted, the homeowners could be put in jeopardy of receiving assistance from FEMA in the event of a fire.

Council Member Schoeffel asked for clarification on the statement that if the City failed to comply with a mandatory duty it could possibly jeopardize its exception to tort liability such that if there were a fire that the City could become a defendant in that action and would not be able to rely on general tort immunity.

City Attorney Munoz replied that if the court were to determine that adopting this map is a mandatory duty, then that statement would be correct.

Dick Dietmeier, Dana Point, stated that he has worked with the Dana Point Times for the last four years. He spoke of their work ethics in getting technical information correct. He felt that if the newspaper's revenue was increased then the paper could employ more reporters.

Mayor Anderson closed the Public Comments.

Council Member Bartlett felt that the Dana Point Times was just a fabulous newspaper and that all of the reporters have been very accurate and fair in all of the reporting.
