

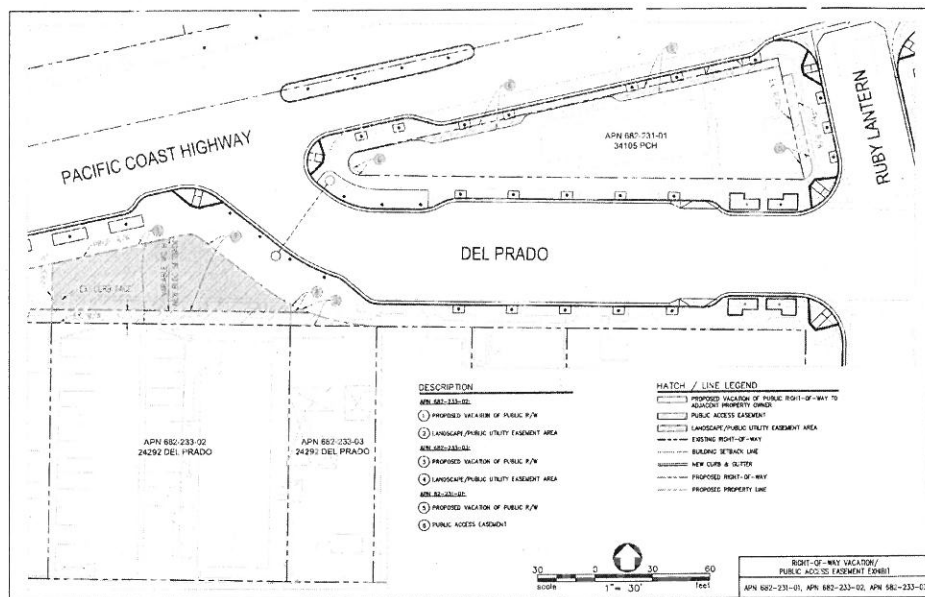

NOTICE OF PUBLIC HEARING**

NOTICE IS HEREBY GIVEN THAT on November 17, 2015, a public hearing will be held by the City Council of the City of Dana Point to consider the following:

NOTICE IS HEREBY GIVEN that the City of Dana Point will be holding a public hearing to discuss the proposed vacation of property and establishment of associated public easements for properties located at 24292 Del Prado Ave. and 34105 Pacific Coast Hwy. This action is a result of the City's realignment of Del Prado Avenue per the attached map. The vacation proceeding is conducted under Chapter 3 (General Vacation Procedure) of Part 3 (Public Streets, Highways, and Service Easements Vacation Law) of Division 9 (Change of Grade and Vacation) of the California Streets and Highways Code, commencing at Section 8320.

On August 24, 2015 the City of Dana Point Planning Commission approved a Coastal Development Permit, number CDP15-0017, determining General Plan consistency of the proposed vacation of portions of Assessor Parcel Nos. 682-233-02, 682-233-03 and 682-231-01. Several easements for public purposes are also required as part of this action.



Any action or proceeding to attack, review, set aside, or void any decision of the Dana Point City Council is controlled by Section 2.50.010 and Section 2.50.020 of the Dana Point Municipal Code. In any such action or proceeding seeking judicial review of, which attacks or seeks to set aside, or void any decision of the Dana Point City Council, shall be limited to those issues raised at the hearing as provided in Chapter 2.50 of the Dana Point Municipal Code.
