


FEDERAL EMERGENCY MANAGEMENT AGENCY FLOOD INSURANCE RATE MAP UPDATE COMPLETE



In January of 2018, the City mailed out a flyer to Beach Road property owners related to coastal flood hazard issues. Included in that notice was information related to the Federal Emergency Management Agency's (FEMA) impending update to the Flood Insurance Rate Maps (FIRM). FEMA has completed the California Coastal Analysis and Mapping Project (CCAMP)/Open Pacific Coast (OPC) study that commenced in 2012. The CCAMP/OPC is the first comprehensive study of coastal flood risk along California's coastline since 1983, and updates the FIRMs along the California's coast, including Dana Point. FIRMs establish and identify areas susceptible to flood hazards. Special Flood Hazard Areas (SFHA) are those areas that have special flood or flood-related erosion hazards. Along the coast, these areas are referred to as Coastal High Hazard Areas (CHHA) due to additional hazards from wind and wave action. The new FIRMs become effective on March 21, 2019.

FLOOD INSURANCE

According to the National Flood Insurance Program (NFIP), if your structure is financed with a federally backed loan and your structure is located in a SFHA on the new flood maps, your lender will require you to carry flood insurance when the new flood maps become effective. FEMA representatives advise that for those structures newly mapped into a SFHA, purchasing flood insurance BEFORE March 21, 2019 and keeping your coverage continuous generally provides the lowest premiums and best rating options now and into the future. Ask your insurance agent now if you qualify for a Preferred Risk Policy.

Even if you do not have a federally backed loan, if your structure is being remapped to a higher risk flood zone you may be able to take advantage of lower flood insurance premiums by purchasing coverage before the new map goes effective on March 21, 2019, and by keeping your coverage continuous. Please be aware that FEMA's updated FIRMs are based on existing flood risk and do not account for or model anticipated Sea Level Rise (SLR). The City is currently assessing SLR under a separate project with funding from a grant awarded from the California Coastal Commission. The City will be scheduling a public workshop this Spring to share the results and solicit feedback on the SLR project.
