The project is located in the City's Coastal Overlay District (the California Coastal Zone) and the Appeals Jurisdiction of the California Coastal Commission at 39 Monarch Bay.

The process includes, but is not limited to contacting the Coastal Commission for the appropriate forms and instructions to file an appeal.

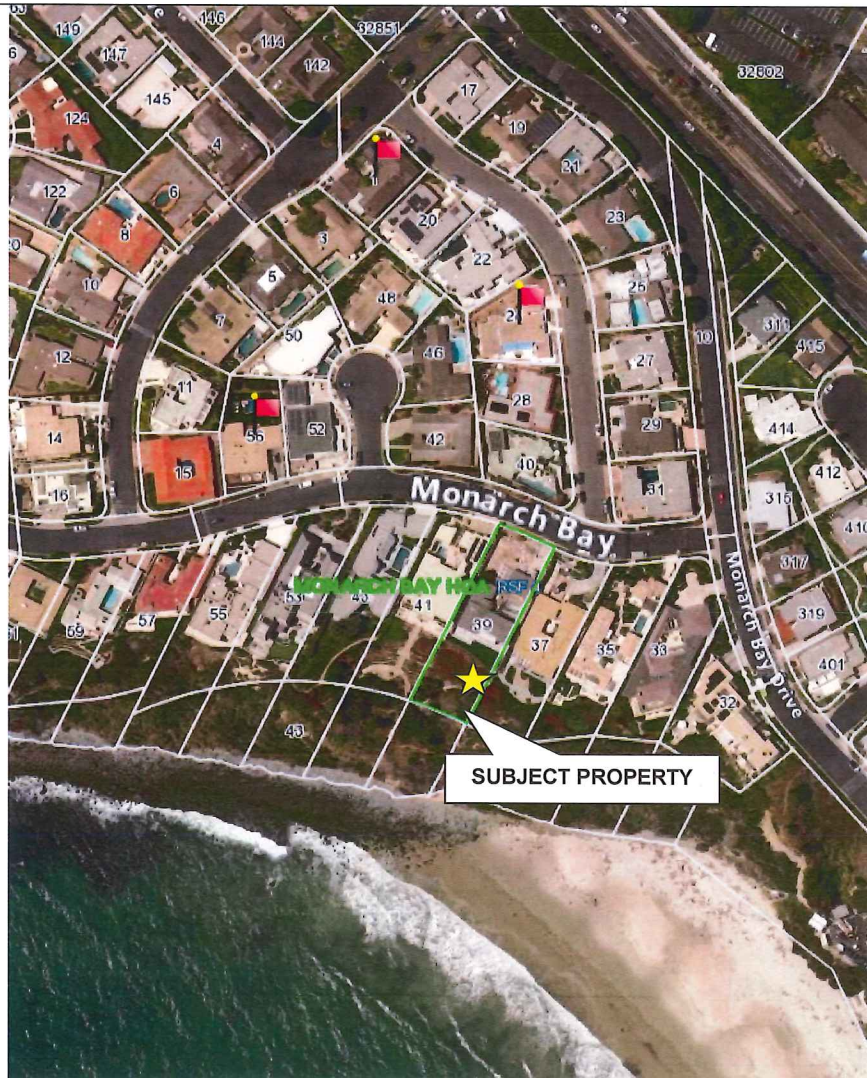
