**NOTICE OF PUBLIC HEARING**

NOTICE IS HEREBY GIVEN THAT a public hearing will be held by the Planning Commission of the City of Dana Point to consider the following:

**Coastal Development Permit CDP20-0020/Minor Site Development Permit SDP20-0027(M):** A request to demolish an existing single-family residence and attached garage, and construct a new 4,490 square foot two-story, single-family residence with attached three car garage of 789 square feet. A Minor Site Development Permit is required for retaining walls greater than thirty (30) inches in height in the rear yard. The project is located in the City’s Coastal Overlay District (the California Coastal Zone) and the Appeals Jurisdiction of the California Coastal Commission at 429 Monarch Bay.

This project may also be appealed to the California Coastal Commission in accordance with Dana Point Municipal Code Section 9.69.090. The process includes, but is not limited to contacting the Coastal Commission for the appropriate forms and instructions to file an appeal.
