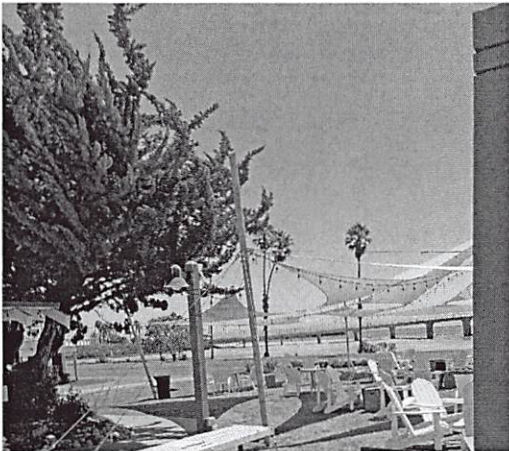
Council,
