NOTICE IS HEREBY GIVEN that on **April 27, 2009**, the City Council of the City of Dana Point will conduct a public meeting and public hearing to consider the following:

RESOLUTION CONFIRMING ASSESSMENTS FOR THE DANA POINT TOURISM
BUSINESS IMPROVEMENT DISTRICT

Said public meeting and public hearing will be held at 6:00 p.m. (or as soon thereafter as possible) in the Dana Point City Council Chamber, 33282 Golden Lantern, Ste. 210, Dana Point, CA 92629.

On April 27, 2009, the City Council will conduct a public meeting and public hearing and consider adoption of a Resolution Confirming Assessments for the Dana Point Tourism Business Improvement District.

This is the final step required by State Law for formation of the Dana Point Business Improvement District. Beginning January 1, 2010, the assessment will be \$3.00 per room night for the four hotels with greater than 190 rooms within the City of Dana Point. The City of Dana Point will collect the assessments monthly from hotels on the same form as that used for the collection of Transient Occupancy Tax receipts and will remit said assessments to the Dana Point Business Improvement District for activities to promote tourism.

Any petition for judicial review of a decision of the Dana Point City Council is controlled by the statute of limitations provisions set forth in Sections 2.50.010 and 2.50.020 of the Dana Point Municipal Code and Sections 1094.5 and 1094.6 of the California Code of Civil Procedure. Any action or proceeding to attack, review, set aside, or void any decision of the Dana Point City Council is controlled by Section 2.50.010 and Section 2.50.020 of the Dana Point Municipal Code. Any such action or proceeding seeking judicial review which attacks or seeks to set aside, or void any decision of the Dana Point City Council shall be limited to those issues raised at the hearing as provided in Chapter 2.50 of the Dana Point Municipal Code. Copies of the procedures for the conduct of City Council public hearings are available from the City Clerk.
