PUBLIC COMMENTS

Carlos Olvera, Dana Point, felt that allowing the demolition of the Doheny House would encourage demolition of remaining Doheny era homes.

Allen Wickstrom, Dana Point, thanked the Council Members who had attended SOCSA's opera gala at the Laguna Cliffs Marriott last week. He reported that they had been able to net over \$15,000 in support of arts education as a result. He recognized Council Member Schoeffel for his generous donation.

There being no requests to speak, Mayor Bartlett opened and closed the Public Hearing.

UNFINISHED BUSINESS

16. CONSTRUCTION AND MAINTENANCE AGREEMENT WITH SCRRA AND OCTA FOR RAILROAD-RELATED SAFETY ENHANCEMENTS, AND POTENTIAL "QUIET ZONE" AT THE BEACH ROAD CROSSING

Mayor Bartlett recused herself at 6:37 p.m. due to a potential financial conflict of interest due to the fact that her residence was within 500 feet of the subject property and left the Chamber.

City Manager Chotkevys provided an introduction of the item and City Attorney Munoz provided a summary of the liability discussion.

Council Member Anderson asked how the train engineer knows when he is approaching a crossing.

Steve Wylie, Assistant Executive Officer of Metrolink, replied that Federal law requires a locomotive engineer to sound a horn at a point at 1/4 mile from the crossing. He stated that there is a whistle board which provides an indication to the engineer when he is 1/4 mile from the crossing.

Council Member Anderson asked if in places where a Quiet Zone is established, the engineer would still have to blow the horn if they see someone on the track.

Steve Wylie replied that was correct and that is the way it is supposed to work. He stated that the train horn rule which was promulgated by the Federal Railroad Administration pursuant to Congressional law vests the responsibility for blowing or not blowing the horn with the locomotive engineer in a Quiet Zone. He added that absent a Quiet Zone, the engineer is required to blow the horn at the whistle board through the crossing no matter what. He added that there were circumstances in the rule that require the engineer to blow horns regardless.

Council Member Anderson asked why would the City want to incur more liability if we do the safety enhancements and it is designated a Quiet Zone if the engineer would still be required to blow the horn in a Quiet Zone.

Steve Wylie replied that the theory behind a Quiet Zone is that if you have equipped your crossing with the safety enhancements you are removing the need for the horn. He stated that the advice they have been giving communities up and down their five (5) county service area is that the best thing that can be done to protect itself from liability is to do the best job you can to protect the crossing by improving the crossing and following the procedure that is outlined in the Federal Train Horn Rule.

Council Member Anderson asked if it was Mr. Wylie's agency's opinion that the ultimate in railway safety would be to do the safety enhancements and to continue to blow the horn at 1/4 mile from each crossing.

Steve Wylie replied that it would be the ultimate but that it was not their decision; that decision was the City's to make.

Council Member Bishop asked where the engineer was located on the train because he has noticed that on the Amtrak that the engine was located in the back of the train.

Steve Wylie replied that the engineer is always at the front of the train regardless of where the engine is located.

Council Member Schoeffel asked how the engineer would know if there were any rail workers in the area.

Steve Wylie replied that the engineer receives a track warrant at the beginning of his run which is the notification that there are track workers along his route.

Council Member Schoeffel asked for clarification of the process for obtaining a Quiet Zone.

Steve Wylie replied that the typical process is what is happening here; the community and the railroad come together to decide what is in the best interest of safety for a particular crossing, once that agreement is reached the City can either say alright we are going to do a Quiet Zone, the improvements get put in place and 21 days later after final notice there is a Quiet Zone. He added that what the City is doing is taking this process one step further; once the agreement is approved, SCRRA will construct the improvements on the railroad as well as the civil improvements on the street side in the interest of expediting this county-long corridor and then at the end of that process, the City will decide whether or not to have a Quiet Zone.

Council Member Anderson asked if there was a horn sequence.

Steve Wylie replied that there is a regulatory requirement for the sequence; two short, long and a short regardless of time of day.

Council Member Bishop asked whether this project has been engineered and besides the dual gates, what other safety enhancements are there for pedestrians.

Steve Wylie replied that Metrolink had commissioned a comprehensive set of grade crossing standards and they had collected best practices from all over the country. He stated that they had focused on improving the safety for non-motorized users. He added that they had come up with the standard for the installation of pedestrian gates, improved paved crossing,

tactile warning strips, a swing gate, and channelization treatments to keep pedestrians out of vehicle paths.

Council Member Bishop asked if Mr. Wylie had seen the crossing designed so that bicyclists would have to get off their bikes and walk across or is it designed where they could ride across the tracks.

Steve Wylie replied that with this project the median will be extended which will be a deterrent to bicyclists to cut across the tracks at a diagonal. He suggested that the City have more pavement markings indicating where the bike trail was.

Council Member Bishop asked Jonathan Shull of California Joint Powers Insurance Authority how long it will take for their committee to determine whether the City would have insurance coverage.

Jonathan Shull, CJPIA replied that there is a Coverage Committee made up from the Executive Committee that will define the document which is approved by the membership. He stated that the Coverage Committee is scheduled to meet in early May and late May and by the end of late May we should have resolution of the issue.

Council Member Bishop asked Mr. Shull what his thought was, should the City have just approved this project.

Jonathan Shull replied that the City has been very diligent in ensuring that it was addressing these issues and should be complimented.

Mayor Pro Tem Weinberg recessed the meeting at 7:15 and reconvened at 7:22 p.m.

Mayor Pro Tem Weinberg opened the Public Comments.

Berni Neal, Capistrano Beach, felt that the existing format of the trains, horns, and landscaping mar the potential that Capistrano Beach has of adding to Dana Point as a beach destination.

Jason Hill, Capistrano Beach, spoke regarding the safety of the railroad crossing. He felt that the safety equipment at the crossing was inadequate.

Hayden Livesay, Capistrano Beach, spoke regarding the decibel level of the train horn and how it affects their children.

Kim Tarantino, Capistrano Beach, spoke regarding the number of times the train horns are sounding each day. She stated that there were 49 trains daily which blow their horns day and night.

Lester Hill, Capistrano Beach, felt that the Quiet Zone would encourage more visitors to the beach and the businesses near the railroad crossing.

Dr. William Sears, Capistrano Beach, stated that the Quiet Zone was an opportunity for the City to improve the quality of life in Capistrano Beach. He felt that the liability would be reduced by improving the rail crossing.

Nick Tarantino, Capistrano Beach, felt that there is no one monitoring the train engineers when they blow their horns and that more oversight was needed.

Robert Bancroft, Capistrano Beach, representing Capistrano Bay Community Services District, stated that the District is in support of the construction of the safety enhancements.

Roger Worthington, Capistrano Beach, spoke regarding the loudness of the train horns and how they affect his family's quality of life.

Mayor Pro Tem Weinberg closed the Public Comments.

Council Member Anderson asked about the change in mandate from four years ago that one of the speakers had mentioned.

Steve Wylie replied that the mandate put in place the general guidelines to blow train horns at a 1/4 mile from a crossing and provides the process by which a community can elect to achieve a Quiet Zone in lieu of that.

Council Member Anderson asked prior to the mandate what the procedure was. Steve Wylie replied that there were various State regulations and locally enforced whistle bans that were inconsistent across the United States. He stated that about thirteen years ago Congress drafted the national legislation that brought some uniformity to the whistle blowing requirements which ultimately resulted in legislation that then implemented the rules existing today.

Council Member Anderson asked if the train horns were getting worse as some of the speakers had indicated.

Steve Wylie replied that he didn't think so, that the train horn rule has a minimum level of 96 decibels and a maximum of 110.

Darryl Johnson, OCTA, stated that in anticipation of the change in the horn blowing rule, that in 2003 the OCTA Board had begun studying the issue in preparing for all 52 crossings within Orange County. He added that discussion with all 34 cities and the County renewed Measure M funding for Quiet Zones and safety enhancements were included.

Council Member Bishop stated that he needs to bifurcate the issues. He added that he had no problem with the safety enhancements and he supports these being built, but that the Quiet Zone was a separate issue. He stated that the City was close to finding out what their liability would be if approved.

Council Member Anderson asked what the timing was for the Quiet Zone process.

Darryl Johnson, OCTA, replied that when the OCTA approved the 70 million dollar county-wide program it came with a very distinct focus to do the safety enhancements in a manner that would leave each crossing in the county with the appropriate set of improvements for the City to either establish and apply for a Quiet Zone. He stated that an application or establishment of a Quiet Zone can not be done until the improvements are completed and the notices are filed.

City Manager Chotkevys felt that the appropriate thing to do if the Council so chooses, was to do the safety enhancements, get some additional information from the City's insurance carrier, and then have the discussion whether the Council wants to go forward with a Quiet Zone.

Council Member Anderson asked what the cost will be to the City to construct the safety enhancements.

Director Fowler replied that the City's current estimated share is \$162,000 and staff would recommend that Council authorize that amount plus a 25% contingency.
