PUBLIC COMMENTS

Bob Moore, Dana Point, reported that Dana Point lost Francis Eddy, a 35 year resident to natural causes at the age of 94 and Lance Corporal David R. Baker, 22 years old of the 5th Marine Regiment last week during active duty in Afghanistan.

Wiley Hall, Dana Point, thanked the City for their support of the car wash to raise money for the 5th Marine Regiment that was held a couple of weeks ago. He reported that the VFW would be handing out poppies at Trader Joe's in honor of Veteran's Day.

Ingrid McGuire, Dana Point, reported that there have been some changes to the water conservation ordinance that the Water District had passed this year. She stated that beginning on November 1, 2009, outdoor watering was to be reduced to only one day per week. She added that District has decided to provide a grace period allowing outdoor watering to be allowed three days per week until February, 2010.

Council Member Bishop asked about the correspondence that had been received and whether these comments would be included in the process.

Director Butterwick replied that yes, all of the public record will be provided to the consultant.

Council Member Anderson asked if the issues brought up in the last correspondence received from Ms. Willinger would be addressed by the EIR consultant.

City Attorney Munoz replied yes.

Mayor Bartlett felt that there will be a very open and transparent process. She encouraged the public's involvement.
