NOTICE IS HEREBY GIVEN THAT a public hearing will be held by the City Council of the City of Dana Point to consider the following:


ADOPTION OF A RESOLUTION APPROVING A REQUESTED STREET NAME CHANGE FROM VIA SUBIDA TO POINTE MONARCH DRIVE PURSUANT TO THE DANA POINT MUNICIPAL CODE

The Pointe Monarch Community Homeowners Association submitted a written request to rename Via Subida to Pointe Monarch Drive. The purpose as presented in the letter from the Homeowners Association is to better identify the community, increase visibility to the traffic on Pacific Coast Highway, and simplify directions. Via Subida is a private street that is maintained entirely by the Homeowners Association. If approved, the majority of the street name signage changed would be on private property, the responsibility of the Association. One public intersection in the City of Dana Point, however, would be impacted and require modification.



In any such action or proceeding seeking judicial review of, which attacks or seeks to set aside, or void any decision of the Dana Point City Council shall be limited to those issues raised at the hearing as provided in Chapter 2.50 of the Dana Point Municipal Code.
