A member of the public pulled this item from the Consent Calendar.

City Manager Chotkevys provided a brief staff report.

Brad Gross, Dana Point, OC Dana Point Harbor, thanked staff and Council for the collaborative effort. He stated that he appreciated the hard work and that he was available for any questions.

Bruce Heyman, San Juan Capistrano, Boaters for Dana Point Harbor, spoke regarding the language in the Land Use Plan. He felt that the amendment with

regard to building heights was not accurately implemented. He encouraged the City to review the Coastal Commission's deliberations on the matter.

Donna Kalez, San Clemente, Dana Wharf Sportsfishing, thanked the Council for their approval of the Land Use Plan.

Jim Miller, Dana Point, felt that the amendments do match what the Coastal Commission had approved. He thanked the City Council for their time and attention.

Council Member Bartlett felt that this was a good plan and to see it come to fruition was rewarding.

Council Member Anderson stated that she shares the concern with Mr. Heyman that the Coastal Commissioner's comments may not have been correctly interpreted. She asked if issues could be corrected during the Coastal Development Permit process.

City Manager Chotkevys clarified with City staff that basically the document is the Coastal Commission staff's interpretation of what was approved and that the City has worked with Coastal Commission staff to ensure that the language is as close to what happened at the meeting.

Council Member Bartlett stated that from what she recalls is the original plan that was presented to the Council had a 65 foot height requirement and that the City Council voted to lower the height to 60 feet. She added that was the plan that was submitted to the Coastal Commission and approved.

City Manager Chotkevys invited Dr. Timothy McLarney to the podium to provide a brief summary of his findings.

Dr. McLarney provided a PowerPoint presentation.

City Manager Chotkevys stated that this report comes as no surprise to him and that it speaks to the job that the City Council has been doing.

Mayor Weinberg stated that during the planning of the Town Center Plan, the people were not interested in a "Big Box Store". He asked why do 34% of the respondents say they want such a store in Dana Point.

Dr. McLarney replied that the survey included random individuals and did not hit on people who were motivated to attend a specific workshop. He stated that the attendees at workshops do not represent the entire community.

City Manager Chotkevys clarified that in Town Center there was no place for a big box store, but maybe in Doheny Village.

Mayor Weinberg opened the public comments.

Judy Smith, Dana Point, Sea Terrace Park Subcommittee, stated that she was pleased to see the library on the list of improvements in the survey. She invited the City Council to the library on Thursdays when the Librarian holds her children's program so they can see how there isn't any parking available.

Mayor Weinberg closed the public comments.

Council Member Anderson stated that this is only part one of our survey, there will be a follow up survey to find out what the City should spend money on and how to pay whether it be bonding measures or taxes. She added that she was pleased with the results of the survey. She stated that she would support the creation of a City newsletter. She added that with the overwhelming number of people that would like to ban smoking in the parks, that the City should look into it.

Council Member Bartlett stated that the City Council does set the agenda, but it is the City staff that carries it out. She felt that the satisfaction survey is reflective of the great work that the staff does.

Mayor Pro Tem Schoeffel thanked Council Members Anderson and Bartlett for their hard work on the survey. He stated that it has been a pleasure talking about these issues with the Council Members and that he would like to move forward and focus on the recommendations.

#### STAFF REPORTS

City Manager Chotkevys spoke of the unexpected passing of Mike Eggers. He stated that Mike had played an important role in the formation of this City and that he will be missed.

City Attorney Munoz reported that he had received an e-mail update regarding plastic bags. He stated that about two years ago, the City of Manhattan Beach passed a ban on plastic bags and that they were challenged by the Grocer's Association on the basis that they could not use a categorical exemption under CEQA to ban the use of the plastic bags. He added that the case had gone through the Trial Court and the Court of Appeal and so far the City has been losing, that the Court has stated that the City needs to create an environmental impact report regarding the regulation. He stated that the case has been appealed to the Supreme Court and that he will keep the Council apprised for possible future participation as a Friends of the Court amicus basis.
