# 18. INTRODUCTION OF AN ORDINANCE AMENDING CHAPTER 13.04, PARKS AND RECREATIONAL FACILITIES REGULATIONS, OF THE MUNICIPAL CODE TO ADDRESS THE ENFORCEMENT OF NO SMOKING IN CITY PARKS

Council Member Bishop and a member of the Public had pulled this item from the Consent Calendar.

City Manager Chotkevys provided a staff report.

Mayor Weinberg opened the Public Comments.

Gwen Drenick, Dana Point, Orange County Tobacco Education Coalition, commended staff on the preparation of the report. She offered the Coalition's support for implementing this Ordinance with technical assistance. She stated that she was proud of her City for proactively promoting a healthy environment and that cigarettes were the #1 litter item in the world.

Mayor Weinberg closed the Public Comments.

Council Member Bishop stated that he was not a proponent of smoking but felt that maybe the Council was jumping to a legislative conclusion too quickly. He added that he did not feel that there was a problem with smoking in Dana Point. He stated that he would like to modify the motion to restrict the prohibition of smoking to activity fields where sports are being played and concerts.

Council Member Anderson stated that she would like to make an alternate motion to support the recommended action as presented.

Council Member Schoeffel stated that he would second Council Member Anderson's motion.

Council Member Bartlett asked Council Member Bishop how smoking would be restricted at sporting events or concerts, would there be a posting beforehand.

Council Member Bishop replied that staff had provided a listing of other cities and what they restrict and the majority of them restrict smoking at activity fields or other places where sports and athletics were being

played. He stated that he would assume that the prohibition would be posted but he was not sure how it would work.

Council Member Bartlett stated that she would second Council Member Bishop's modified motion.

Mayor Weinberg asked about the procedures of handling two motions.

City Manager Chotkevys clarified that Council Member Bishop's immediate motion died for lack of a second. He stated that Council Member Anderson offered a substitute motion which was seconded so he believed that there is a motion to approve as presented with a second.

19. INTRODUCTION OF AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF DANA POINT, CALIFORNIA AMENDING CHAPTER 13.04, PARKS AND RECREATIONAL FACILITIES REGULATIONS, OF THE MUNICIPAL CODE TO ADDRESS THE CENTER FOR NATURAL LANDS MANAGEMENT DANA POINT PRESERVE OWNED AND OPERATED BY THE CENTER FOR NATURAL LANDS MANAGEMENT

Council Member Bishop had removed this item from the Consent Calendar.

Council Member Bishop stated that Dana Point loves their dogs and felt that it didn't make any sense that we would restrict them. He made a motion to strike the meandering trail and the revetment from the Ordinance.

Council Member Anderson stated that Council had held a first reading of an Ordinance allowing dogs on the trails, but tonight this is a first reading of another Ordinance. She asked where the appropriate place to address dogs was or was this a replacement Ordinance.

City Manager Chotkevys clarified that tonight's Ordinance has been brought forward at the request of the Center for Natural Lands

Management. He stated that there is a trail easement that runs along the Center and since this is private property, they want the City to be able to enforce that there be no trespassing into the Environmentally Sensitive Habitat Areas (ESHA) and that dogs not be permitted. He added that their concern is that these are narrow trails into ESHA that if a dog gets off leash and the owner would have to go into the ESHA disrupting the flora, fauna, or endangered species.

Director Fowler added that this Ordinance affects not only dogs, but hours of use, trespassing, throwing items, bicycles, skateboards, and rollerblades on private property.

Council Member Bishop asked if this affected the meandering trail and the revetment.

Director Fowler replied that those trails were not a part of this Ordinance, that this only affected the private property.

Council Member Anderson stated that the City Council was being asked to amend an existing Ordinance to include the Center for Natural Lands Management.

Council Member Bartlett asked if the majority of the problems were being caused by dogs off leash or on too long of leash.

City Manager Chotkevys replied that on these particular trails there are environmentally sensitive habitat areas that need a set of rules in place to protect these assets. He stated that the Center for Natural Lands Management wants the City to be able to enforce no trespassing and no dogs on the trails.

Norma Struthers, Dana Point, thanked the City Council for the new pedestrian bridge on Pacific Coast Highway. She spoke about a recent news article that listed the 10 dirtiest hotels in the United States and one of our City's hotels was listed.

Alan Wickstrom, Dana Point, thanked the City Council for attending the Star Studded Spectacular last Sunday which was a fundraising event held in support of the new theater for Dana Hills High School. He announced the next concert of the Dana Point Coastal Arts series was to be held at St. Edwards Church this Thursday, March 11. He stated that tickets were \$12 for adults, \$8 for students and military. He added that the Monarch Beach Sunrise Rotary was sponsoring a diamond dig at Baby Beach at noon on Sunday with great prizes to be won. He stated that on March 28 SOSCA was holding their 7th Annual Opera Night at the Laguna Cliffs Marriott Resort and on March 27 is concert night at Dana Hills High School.

Joanna Adrian, Dana Point, spoke regarding the Dana Point Library and the current condition of the building.

City Manager Chotkevys replied that he had not been aware of the issues at the library and added that Kevin Evans will contact County staff to follow up.
