A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DANA POINT, CALIFORNIA, ACTING AS THE GOVERNING BODY OF COMMUNITY FACILITIES DISTRICT NO. 2006-1 OF THE CITY OF DANA POINT, AUTHORIZING AND ORDERING JUDICIAL FORECLOSURE OF CURRENT AND FUTURE DELINQUENT SPECIAL TAXES IN SAID DISTRICT PURSUANT TO THE MELLO-ROOS COMMUNITY FACILITIES ACT OF 1982 AND TAKING CERTAIN ACTIONS IN CONNECTION THEREWITH; and

- 2) authorize City personnel, in conjunction with the City Attorney and other City consultants, pursuant to Government Code Section 53356.2: (a) to record notices of intent to remove the delinquent special taxes from the tax rolls, and (b) to authorize the applicable County officials remove current and future delinquent special taxes from the tax rolls; and
- 3) authorize the City Attorney to prosecute a foreclosure action and to collect, in the name of the city an on behalf of the owners of the bonds, all amounts due on account of the delinquent special taxes with respect to the property identified in referenced Resolution.

RECOMMENDED ACTION: That the City Council adopt a Resolution entitled:
