**CLOSED SESSION ANNOUNCEMENT**

City Attorney Munoz stated that he had two items to report. The first item was the matter of the South Orange County Wastewater Authority (SOCWA) versus the City of Dana Point litigation; he stated that this was a lawsuit brought against the City in connection with the former mobile home site down on Del Prado and Pacific Coast Highway. He added that SOCWA brought a CEQA lawsuit challenging the City's approval of a Zone Change and General Plan Amendment for the project. He stated that the allegation in the lawsuit is that the City had to complete an Environmental Impact Report to take into consideration the odors that were emanating from the wastewater facility and the impact that they would have on the new development. He added that the court of appeal had recently ruled in the City's favor in that case and in essence indicated that the point of CEQA is to mitigate impacts from a project to allow the project to go forward not to require every project to mitigate existing impacts in able to go forward.

He stated that the second item relates to Item C from the Closed Session Agenda which is Conference with Labor Negotiator. He added that there is a continuation of that discussion that the City Council has indicated that they would like to have occur in open session. He stated that the request is to add an item, Item 17, to the Agenda under New Business which is a continuation of Item C from the Closed Session Agenda.

Mayor Pro Tem Lara Anderson asked why this report was taking so long and why did the consultant need an additional year.

Director of Community Development Butterwick replied that the primary issue is the on-going evaluation of the geotechnical conditions of the property which has proven to be very complex as it will have an impact on the ultimate design, siting and cost of the project.

Mayor Pro Tem Lara Anderson asked if there would be more opportunity for the public to comment on the project during this extension period or has that passed.

Director of Community Development Butterwick replied that the next available opportunity for public input will be upon completion of the draft EIR. He stated that the draft EIR will be circulated for 45 days at which time there will be an opportunity to provide comments. He added that there will be additional opportunities for the public to comment when the City starts the public hearing process.

**PUBLIC COMMENTS**

Vonne Barnes, San Clemente, stated that the gates at the mid Strands access and central Strands access at Strand Vista Park were not being locked open during daytime hours of operation in accordance with Dana Point City Ordinance 10-05 and Municipal Code 13.04.030 hours of use (h). She stated that since the gates are not securely

locked open, they can swing closed and automatically lock shut. She reported that a family of tourists had been locked in on June 25th after 10:00 a.m. She felt that it would be a mistake for the City to appeal the court rulings and a waste of the tax payer's money.

Bob Becker, Dana Point, announced that during the month of August the animal shelter has a special promotion "\$9 for 9 Lives" where cats and kittens can be adopted for a fee of nine dollars. He stated that also included in the adoption will be a "kitty starter kit" which provides the adopter the necessities needed for the first couple of days. He added that the kit will include a bag of kitty litter, litter pan, scoop, food and water bowls, a bag of dry cat food and a cat toy. He stated that each cat has been spayed or neutered and micro-chipped. He asked everyone to spread the word.

Robert Fowler, Dana Point, spoke about the Concerts in the Park at Sea Terrace Park. He stated that he lives in Niguel Shores and felt that it was a great event and that everyone seemed to have had a great time. He thanked the City Council and staff for all of their hard work in bringing these concerts to the community.

Janet Saner, Dana Point, read a letter into the record from her neighbor in Niguel Shores, Neil Singer who could not attend the Council meeting. He felt that the concert was not consistent with the use of a passive park.

Cyndi Elders, Dana Point, stated that she was able to walk to the concert and had a great time. She felt that everyone had done a fantastic job.

Steve Stewart, Dana Point, stated that he did not support using Sea Terrace Park for the concerts as it was not a passive use. He felt that the area is made too congested with traffic and his community did not want to support parking for the concerts.

Elenna Erkeneff, Dana Point, spoke regarding the hours that the Mid and Central Strand Access ways were open to the public.

Denise Erkeneff, Dana Point, felt that people were being denied access to the beach and that the gate should be removed.

Rick Erkeneff, Dana Point, felt that the gates at Strands Beach were a hazard and that they need to be removed.

Henry Chou, Rancho Santa Margarita, spoke regarding the gates Strands Beach and felt that they should be removed.

Karin Schnell, Dana Point, stated that Dana Point Coastal Arts has had the opportunity to be a part of the City's Concerts in the Parks these last two weekends in the two different locations. She felt that the City has done a lot to beautify, maintain, and improve all of our parks for our citizens and surrounding community to enjoy.

### **PUBLIC COMMENTS**

There were no additional Public Comments received.

### **STAFF REPORTS**

City Manager Chotkevys thanked the City Council for their generosity and allowing staff to have the days off. He reminded everyone that the main body of the 5th Marine Headquarters Company will depart on or about the end of the second week of August for Afghanistan where they will become a regimental combat team. He stated that the 5th Marine Regiment Support Group was planning a sendoff for them. He asked that everyone keep the Marines in their thoughts.

City Attorney Munoz provided an update on the California Supreme Court ruling in the case involving the City of Manhattan Beach where the City was sued by the plastic bag industry. He stated that the Court had determined that an EIR was not required for cities to regulate the use of plastic bags. He clarified that the City of Dana Point was not making any effort to restrict Strands Beach to anyone. He stated that there was an access point at the north end and an access point at the south end that are always open when the beach is open. He added that the Mid Strand access point where the gate was is only closed during the nighttime hours. He stated that it was well known that the City Council has been some litigation about the City Council's decision to enact some public nuisance measures with respect to that but to give the impression as some of the speakers did tonight that people don't have access to the beach is simply false and the public should be aware that there is access at all times that the beach is open.

### **COUNCIL REPORTS, INCLUDING CITY RELATED MEETINGS ATTENDED**

Council Member Weinberg reported that he had turned in his list of meetings attended to the City Clerk. He stated that the 5th Marine Support Group was coordinating an effort while the troops were deployed to adopt-a-family or troops overseas. He added that if you would like to help, contact Pete Hammer, Nancy Jenkins, or Terry Rifkin. He wished everyone a wonderful rest of the summer.

Council Member Brough stated that he had turned in his list of meetings attended to the City Clerk. He asked for support from the City Council to discuss a sex offender ordinance at a future meeting. He recognized the Green family of Dana Point who lost a member of their family who had been a long time resident of Dana Point, John Green who had died last week at the age of 87 in Mississippi. Spoke at three different locations for the California redistricting hearings; Fullerton, San Francisco, and Sacramento. She stated that the first draft map split our City in half. She stated that the City Council is very appreciative of all of the letters of support from the residents, community leaders, and business leaders as well. She added that the second draft map that has come out has Dana Point whole again and we are secured in the south Orange County district. She stated that we need to continue to contact the Commissioners and the staff there so when the final map comes out, Dana Point is still whole and in the south Orange County district.
