NOTICE IS HEREBY GIVEN THAT a public hearing will be held by the Planning Commission of the City of Dana Point to consider the following:

Coastal Development Permit CDP 07-06 and Site Development Permit SDP 07-17 at 33821

Mercator Isle: A Coastal Development Permit for an addition to an existing 2,031 square foot non-conforming single-family residence in the Niguel Shores Community, within the Coastal Overlay District. The proposed addition is part of a remodel to the existing single-family residence which will increase the floor area by 318 square feet. The structure is non-conforming as to setbacks, therefore a Site Development Permit is also required.
